Renewal of Recognition for Classes I to VII (EM) (without aid) during the

academic years from 2017-2018 to 2026-2027 in respect of Sri Vani

Vidyalaya English Medium School, Survey No.1284/4, Mangasamudram

Village, Sathapeta, Chittoor District, subject to following conditions:

1) That the society shall abide by the instructions / rules and regulations

made by the Government of authorized Officer from time to time

2) That the Educational Institution shall serve the needs of the locality and

particularly

3) That the Institutions shall adopt the curriculum syllabus prescribed from

time to time.

4) The School timings, vacations and non-school holidays shall be as prescribed

by the Govt. from time to time

5) That the qualified staff within the age limits prescribed by the Government

for Govt. Employees shall be appointed as per the staff pattern

6) That the results of the institution shall be satisfactory every year

7) That the records/accounts shall be rendered to the District Educational

Officer every year by July of the next

8) That the list of Governing body shall be forwarded to the District

Educational Officer every year

9) That the pay structure / fee structure shall be as per the Government orders

10) That all the conditions prescribed in the G.O.Ms No. 1284/4

not specified in these orders shall be as per the Government orders

11) That the school shall not be closed without the permission of the District

- 12) That the school shall be closed or permitted to be closed only from the date on which summer vacation is declared.
- 13) That the society shall be submit proposals for renewal provisional recognition sufficiently in advance i.e., at least 6 months prior to the date of expiry of the renewal.
- 14) Only single section in each class is recognized.
- 15) The Management should follow the rules and regulations prescribed in Circular Memo.No.21748/D1/1997, dated 16.02.1998 and other orders of transport authorities regarding maintenance of school vehicles, maintenance of vehicles and ensure safety of children, and shall obtain fitness of school vehicles from the transport authorities as prescribed by the Govt. from time to time.
- 16) The Management should have adequate personal guide, the movement of the children to ensure the road safety and transportation.
- 17) The Management should adhere the instructions issued by the District Educational Officer, Chittoor from time to time.
- 18) The occupancy NOC issued by the DFO is valid for a period of one year from the date of issue and he should renew every year.
